Subject: Issue of No Objection Certificate for affiliation with the C.B.S.E. New Delhi to the Chanakya School Fazilka, Korian Wali Road, Penchanwali District Ferozepur.

Sir,

Please refer to the subject cited above.

After minutely scrutinizing the recommendations made by district Education Officer (S.Sec.) Ferozepur and the DPI (S.Sec.) Punjab Chandigarh and the document produced by the management of the school along with its affidavit, a No Objection Certificate from the government is issued on the following conditions.

1. That in future if on any complaint, Inspections it comes to the notice that in obtaining the No Objection Certificate from the government you have applied for on false facts. Or you have not complied with the directions issued by the Punjab Government from time to time and the conditions mentioned in your affidavit are not being complied with, in that case the No Objection Certificate will be withdraw at any time.
2. It would be mandatory that arrangement for teaching the subject of Punjabi up to 10th class in your school would be made properly, and the C.B.S.E. New Delhi would take steps for holding an examination of Punjabi in such schools. It is also pointed out that on any violation of the conditions prescribed; the No Objection Certificate issued hereby would stand the NOC withdrawn forthwith.
3. After affiliation with C.B.S.E. New Delhi, The management of the school would be bound to give its staff, pay and other emoluments as per terms and conditions of Government employees. In case of its non compliance the No Objection Certificate issued here would be withdrawn.
4. That yourself and your management would make it ensure that any required information at any stage sought by the District Education Officer, Ferozepur or any other senior officer of the Education Department would be provided immediately and needed assistance would also be given to these officers.
